DESIGN STORY OF THE PRODUCT

The Klint Chair, designed in 1936, epitomises the philosophy of its creator, Kaare Klint, who laid the foundations for Danish design and inspired great designers such as Børge Mogensen. Serving as a modern adaptation of a traditional English Country Chair, the Klint Chair exudes classic elegance. With its high back and carefully calibrated ergonomics, it becomes an exceptionally comfortable chair suitable for both dining and as a statement of craftsmanship.

- Increase the use of recycled materials

MATERIALS

Armchair with solid wood frame and a woven paper cord seat. Molded veneer back with core in the same wood as top veneer.

ENVIRONMENTAL DATA

The whole product incl. packaging material

Recycled content: 15 %

Virgin content: 83 %

LIFE CYCLE ASSESSMENT DATA

The Climate footprint = 23 kg of CO₂e in a product screening validated by the danish company, Målbar. This result is based upon the lowest emitting variant of the model and is Målbar's estimate on the outcome within the boundaries of 20-32 kg of CO₂e.

The CO₂e accounts for carbon dioxide and other gases e.g., methane and nitrous oxide. The screening complies with the European LCA-rules PEF (Product Environmental Footprint) meaning that it covers the whole product life cycle incl. extrusion of raw materials to end-of-life handling.
